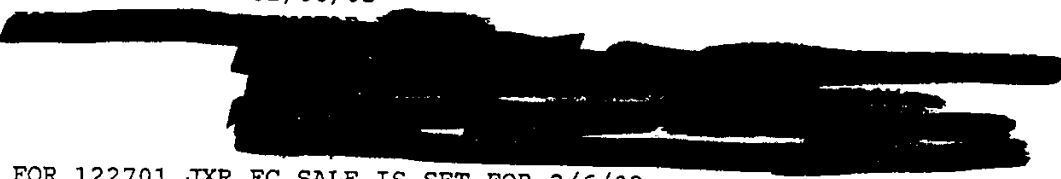

*** ATTORNEY'S NOTE:

The Above Note taken on 01 14 02 by "AKI" concerning "Reinstatement" was in response to Mr. Filson's request to use his own money held by Wells Fargo in order to stop the pending foreclosure. "AKI" was deposed in October 2004 Her statement was that Wells Fargo's position remained firm that they had not made an error in proceeding with foreclosure and that the \$908.00 held by Wells Fargo in "suspense" could not be applied to the delinquency balance.

The Note Reads:

Advised Debtor that the reinstatement figures are correct ... Debtor was wanting to add the funds that are in suspense to the reinstatement quote ... Advised Debtor that cannot be done.

At the time of this Note, the reinstatement balance was quoted as Approximately \$9,000.00. Mr. Filson was ready willing and able to pay \$8,100.00. The additional \$908.00 in suspense would have paid the reinstatement amount in full. However, Mr. Filson was advised, "That cannot be done."



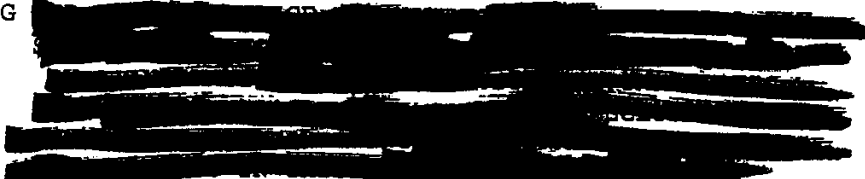
